## Regulator to Licence Second 3G Operator

Mobile phone users in Guernsey will soon be able choose their provider of 3G services following a decision by the regulator to award another licence. Today the Office of Utility Regulation (OUR) has set out the terms under which it will licence another 3G operator in competition with Wave Telecom, and is inviting companies to apply for that licence which will be awarded by late summer 2006.

"The market for 3G services is now looking much more positive than when the first licence was awarded to Wave Telecom in 2003", said Jon Buckland, Director of Policy at the OUR. "Competition in the 2G market has increased the range of services on offer, and brought prices down, and we think it can only be beneficial for 3G users as well."

The formal Tender Document is available to interested parties upon payment of  $\pounds 5,000$  and it sets out the detailed terms of the competition and minimum requirements that a successful applicant will have to meet. Applications must be lodged with the OUR by  $13^{\text{th}}$  April 2006 and the Office intends to award the licence by August 2006. The cost of the licence is £250,000, the same as paid by Wave Telecom for its 3G licence.

"Given the level of interest in mobile services, we are confident there will be a strong level of interest in this licence" said Jon Buckland. "There has been significant investment in the telecoms market in Guernsey since it was opened to competition which is a strong endorsement of the regulatory regime that has been put in place. Further competition in the mobile market can only be good for Guernsey consumers in the long term."

3G is the third generation of wireless communication, which includes digital transmission; however it also permits per-user and terminal mobility by providing a single mobile communication service, adjusted fro broadband applications, including voice, data and multimedia streams, that will support higher data speeds (2Mbps), with the objective of ultimately supporting upto 155Mbps.

Where competition is not yet effective or where it is not feasible, the OUR regulates prices and quality of services to end customers.
