Mast Audit spot-check Results published

A recent survey of 16 mobile mast sites in the Bailiwick has found that each is within the safety guidelines set by the OUR. The results of the audit are published today along with an updated register of all Bailiwick mobile sites.

"Each site selected for the spot-check falls with the internationally accepted guidelines, which is pleasing to see," said Rosie Allsopp, Office Manager at the OUR. "This is the fifth audit of sites carried out since 2004 and on each occasion the sites audited have all complied with the guidelines. I hope the results of this independent audit will reassure islanders that the telecoms companies are continuing to meet their obligations."

A full audit of all sites operational in the Bailiwick was undertaken in 2004 and again in 2008 with spot-checks on selected sites in 2005, 2009 and again this year. The audit is the latest in a series carried out since 2004 and was conducted to ensure that mobile operators continue to comply with the guidelines laid down by the International Commission for Non-Ionising Radiation Protection (ICNIRP).

An updated register of all mobile mast sites in the Bailiwick has also been published by the OUR. It shows that the total number of sites now stands at 77 across the Bailiwick, six more than in 2009. Almost half of all sites are shared by more than one operator.
