OUR Consults on further Postal price increases

The Office of Utility Regulation (OUR) is considering whether to accept an application from Guernsey Post to increase its charges for mail sent to the UK. The application from Guernsey Post follows a £1m increase in the charges Royal Mail bills the company for handling mail into the UK for the rest of the year to March 2012.

This is an increase of nearly 10% compared with what Guernsey Post was paying in 2010-11.

"Postal customers in Guernsey are reliant on Royal Mail for the 'last mile delivery' of post to homes and businesses in the UK and for the onward handling of mail to international destinations. Therefore any change in the charges Royal Mail applies for such services has a direct impact on what we pay locally for postal services," said John Curran, Director General at the OUR. "When Guernsey Post's price control was set in January we were aware further changes were likely. However, while these proposed price increases are significant and unwelcome, we are of the view that it is right that they are passed on to customers."


Guernsey Post proposal is that the price of sending an ordinary letter to the UK should go up by two pence to 47p, a Large Letter should increase by three pence to 61p and a packet should cost nine pence more. Parcel prices would go up by $\pounds 2$, whatever their weight, reflecting a nearly doubling of the charge that Royal Mail makes to Guernsey Post.
