Direction issued under Section 1(2) of the Electricity (Guernsey) Law, 2001

The Director General in exercise of the powers conferred on her by section 1(2) of the Electricity (Guernsey) Law, 2001, hereby directs:-

Exemption

- 1. The Persons specified in paragraphs 3 and 4 are exempt from the requirement to hold a licence under section 1(1)(a) of the Electricity (Guernsey) Law, 2001 and
- The persons specified in paragraph 5 are exempt from the requirement to hold a licence under section 1(1)(c) of the Electricity (Guernsey) Law, 2001.

Generation

- **3.** Persons (other than licensed generators) who do not at any time provide electrical power from a generation station except for;
 - (a) the purposes of supply to themselves; or
 - (b) where the person is a company, for the purpose of supply to that company and associated companies;

where the person or the company and associated companies are situated on the same site as the generation station.

For the purpose of this condition, premises shall be treated as on the same site if they are:

- (a) the same premises;
- (b) immediately adjoining each other; or
- (c) separated from each other only by a road, watercourse, or other

premises (other than a pipeline, electric line or similar structure), occupied by the consumer in question or by the person who generates the electricity.

- **4.** Persons who do not provide more than 500 kilowatts of power disregarding
 - (a) power provided for the purposes set out in paragraph 3, and
 - (b) power temporarily provided in excess of 500 kilowatts due to technical circumstances outside the reasonable control of the person providing that power,

and where the generation plant providing the power has a declared net capacity of less than 2 megawatts.

For the purposes of this condition "**declared net capacity**" means the highest generation of electricity which can be maintained indefinitely without causing damage to the plant less so much of that capacity as is consumed by the plant.

Supply

- 5. Person (other than licensed suppliers) who do not supply any electricity except for;
 - (a) electricity which they generate themselves (or where the person is a company, electricity which is generated by that company or an associated company); or
 - (b) electricity which they generate themselves (or where the person is a company, electricity which is generated by that company or an associated company) together with electricity which is supplied to them by a licensed supplier.

Miscellaneous

- **6.** The Director General may amend, revoke, suspend or replace this exemption from time to time.
- 7. This exemption comes into effect on the 1st day of February 2002 and will continue in force until such time as it is revoked, suspended or replaced by the Director General.
